Statement on the draft law on Status of non-governmental organisations in Angola

5 July 2023

We express our deep concerns on the risks posed by a new draft law regulating civil society in Angola, urging international organizations, governments, and other stakeholders to join us in support of the fundamental freedoms and constitutional rights of the Angolan people by demanding from the Angolan authorities to withdraw the law in its current form.

The draft law "Estatuto das Organizações Não-Governamentais" (Status of non-governmental organisations), was approved in general terms by the Angolan National Assembly in May 2023. The law is currently undergoing revision by a special committee before being reapproved by the Parliament and subsequently sent to the President for final sign off. Should this happen, NGOs in Angola would no longer have the right to operate freely, independently, and safely, and their voices ensuring transparency and accountability of government action will be silenced.

It is not the first time that the Angolan political regime has attacked national and international civil society organizations operating in the country. In March 2015, former President José Eduardo dos Santos issued a Decree regulating the action of civil society organizations which was challenged and found illegal by the Constitutional Court of Angola. Since the lead-up to the national elections in 2022, Angola has witnessed a further increase in restrictions on the work of civil society organizations. These restrictions impede the right to peaceful assembly and have led to the arbitrary arrest of citizens expressing dissenting views. The introduction of the draft law comes therefore in, and will exacerbate, an already restrictive environment for civil society in the country.

Equally as concerning is that the new legislative initiative led by President João Lourenço is being introduced under the pretext of enhancing compliance with the Financial Action Task Force (FATF) Recommendations, addressing risks related to terrorism and money laundering.

That a key measure against transnational corruption such as FATF is being misused by one of the countries in the world mostly affected by illicit financial flows to seriously jeopardize the freedom and autonomy of civil society organizations undermines Angola's commitment to addressing illicit financial flows. It is many of these civil society organizations the law would impact that have proved to be central for advancing the fight against corruption, the defence of human rights and sustainable development in Angola.

Among the most concerning provisions of the law are:

- the establishment of a new civil society organizations supervisory body dependent on the government that will be responsible for monitoring, supervising, and, most worryingly, dissolving these organizations without recourse to judicial proceedings;
- the imposition of onerous registration, inspection and monitoring requirements, mandating civil society organizations to disclose their sources of funding to this government body;
- funding restrictions from organizations or individuals "involved in activities that call into question constitutionally enshrined interests". This vague definition may impede collaboration with international organizations and partners;
- the prohibition of engagement in "subversive acts or acts that could be perceived as such", posing a serious threat to freedom of expression and assembly for civil society.

Furthermore, the law was drafted and introduced in Parliament without consultation or prior notice to relevant stakeholders, including civil society organizations.

The restrictive measures outlined in the draft law contradict Angola's commitments under international law to uphold freedom of expression and assembly, principles that are also enshrined in the Angolan Constitution.

We express our strong solidarity with Angolan civil society organizations in their fight for freedom, justice and independence.
